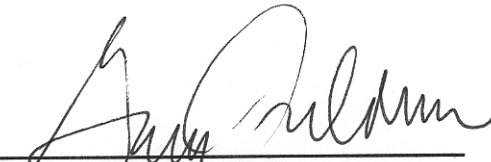

SUBJECT: Ratify the Second and Third Amendment to Agreements No. 02-255, 02-256 and 02-257 with San Bernardino County, Ryan White CARE Act, Title I

RECOMMENDED MOTION: That the Board of Supervisors

- 1) Ratify the Second Amendment to Agreement 02-255 and 02-256 between San Bernardino County and the County of Riverside Community Health Agency, Department of Public Health, for a total increase of \$14,000;
- 2) Ratify the Second Amendment to Agreement 02-257 and the Third Amendment to Agreement 02-255 and 02-256 between San Bernardino County and the County of Riverside Community Health Agency, Department of Public Health to extend the period of performance from March 1, 2002 through June 30, 2003 in the amount of \$213,169;
- 3) Authorize the Chairperson of the Board to execute four (4) originals of said Amendment on behalf of the County, and,
- 4) Direct the Clerk of the Board to retain one (1) original Amendment and return (3) executed original Amendments each to Community Health Agency Contracts Administration for further processing.

BACKGROUND: The Ryan White CARE Act was enacted in 1990 to provide federal funding for comprehensive health and social services for persons who are living with the human immunodeficiency virus (HIV). The Federal Health Resources and Services Administration (HRSA) provides funding through Title I of the Ryan White CARE Act to geographic areas disproportionately affected by the HIV epidemic. Funds from these agreements provide medical, dental, and pharmaceutical care for people living with HIV at the Riverside Neighborhood Health Center, Riverside County Regional Medical Center and the Hemet Family Care Center. In addition, funds are used to provide intensive outreach services to communities of color who continue to be greatly impacted by HIV infection. Outreach services assist clients in enrollment and continued participation in care and treatment programs.

The San Bernardino County Department of Health (grantee) has determined that the contract with Riverside County should be increased a total of \$14,000 for the period beginning March 1, 2002 through February 28, 2003 for Outreach Services. In addition, the San Bernardino County Department of Health (Grantee) has determined that the contract with Riverside County should be extended by four **(4)** months and increased by a total of \$227,169 to continue providing services through June 30, 2003.

FINANCIAL DATA:

Expenditures are fully reimbursed by the County of San Bernardino and require no General Funds, and are included in the Department's Fiscal year 02/03 budget.

These Amendments were not received until mid-February, delaying this Form 11.
