RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Ratify the Second Amendment to the Agreement between Riverside County Community Health Agency, Department of Public Health and Inland Empire Health Plan (IEHP) in an estimated amount of \$8,000 for the period of performance of July 1, 2006 through June 30, 2007. Thereafter, the term of the Agreement shall automatically be extended for two (2) successive one (1) year terms, with the completion date of June 30, 2009, and
- 2) Authorize the Chairperson of the Board to sign four (4) originals of the Amendment on behalf of the County.

SUBJECT: Ratify the Second Amendment to the Agreement between Riverside County Community Health Agency, Department of Public Health and Inland Empire Health Plan

BACKGROUND: IEHP, as a Local Initiative Medi-Cal Managed Care Plan, is required to coordinate public health services with the public health departments of Riverside and San Bernardino counties. Since December 1, 2000, the Community Health Agency has been contracted by IEHP to provide smoking cessation classes to its members. The smoking cessation program includes four 2-hour relapse/support group, available in English and Spanish, and distribution of education materials and participants incentives.

In this Second Amendment, IEHP is requesting to continue this contract with the Community Health Agency for these classes.
