2. Authorize the Chairman of the Board to ratify the attached contract, HU 3262-00, between DPSS and Housing Authority of Riverside County;
3. Authorize the Purchasing Agent to sign ministerial amendments with the Housing Authority, not to exceed the maximum amount of the Grant Agreement (\$124,860); and
4. Authorize the Director of DPSS to administer the agreement with Housing Authority.

BACKGROUND:

On June 7, 2005, (Agenda Item 3.60), your Honorable Board authorized DPSS to submit an application for Homeless Assistance funds to the U.S. Department of Housing and Urban Development, which included renewal funding for a shelter plus care program operated by Housing Authority. HUD approved the application and allocated \$124,860 for a 1-year period. Housing Authority provides tenant based rental assistance for homeless mentally ill persons.

The previous one-year grant ended on June 16, 2006. HUD executed the attached renewal grant agreement on December 6, 2006, which we are forwarding to your Board for approval. Housing Authority's project goal is to continue to serve 19 individuals under the attached renewal grant.
