SUBJECT: Amendment to the Professional Medical Services Agreement between the County of Riverside and De Anza Obstetrics and Gynecology Medical Group, Inc.

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Ratify the amendment to the professional medical services agreement, effective January 1, 2007; and
- 2) Authorize the Chairperson to execute three (3) copies of the agreement; and
- 3) Retain one (1) copy of the agreement and return two (2) copies of the executed agreements to Riverside County Regional Medical Center (RCRMC) administration for distribution.

BACKGROUND: On July 14, 1998, Agenda Item no 3.24, the Board of Supervisors approved the agreement with De Anza Obstetrics and Gynecology Medical Group, Inc., for the provision of professional Obstetric and Gynecological services. This agreement was 1st amended effective July 1, 2001, agenda item no. 3.41 adding nurse midwife and high risk fetal care clinic services. The agreement was further amended on July 10, 2001 agenda item no. 3.50 and September 24, 2002 agenda item no 3.32 adding necessary housekeeping language removing references to the Health Services Agency and adding updated professional liability indemnity language.

BACKGROUND (Continued): The 4th Amendment effective October 1, 2004, agenda no. 3.14 added elder abuse and neglect professional services to the agreement. This 5th amendment adds the services of two (2) P.A.'s fellowship trained in OB/GYN care to provide services in the women's health clinic and to assist in the labor and delivery at the Hospital and removes elder abuse services for the agreement.

This Agreement has been reviewed and approved by County Counsel.
