BACKGROUND: By Minute Order 3.63 of September 26, 2006, the Board entered into an agreement with Hillcrest Contracting, Inc. of Corona for the repair of a portion of Riverview Drive, from Avenue Juan Diaz to Peralta Place in the West Riverside area of Riverside County. The authorized amount of the contract was \$158,133.20. The total amended contract amount (including Change Orders and quantity adjustments) is \$161,645.75, which is 2.2% more than the originally authorized amount.

This work was completed in conformance with the plans and specifications on December 29, 2006. The work was inspected by the Construction Engineering Section of the Transportation Department. Work Order 4504130104
