COUNTY OF RIVERSIDE PLANNING DEPARTMENT STAFF REPORT

PROJECT DESCRIPTION AND LOCATION:

Conditional Use Permit No. 3564 proposes to permit a contractor's storage yard for a construction and roofing company to store equipment, asphalt materials and shingles, construction and asphalt waste, including six (6) parking spaces and 2,025 square feet of existing and proposed landscaping area on a 1.4 gross acre site. The existing 1,224 square foot office building and two (2) storage buildings, totaling 1,500 square feet, will be permitted and subsequently redeveloped. The conversion of the existing small structures from one use to another (as described above) will have minor modifications in the exterior of the structure.

The project site is located in the Community of Belltown within the Jurupa Area Plan in Western Riverside County; more specifically, northerly of 28th Street and westerly of Avalon Street.

BACKGROUND:

The project was cited by the Riverside County Code Enforcement Department on May 2, 2007 for an unpermitted land use and for operating an unauthorized business without Planning Department approval (CV07-3095). The property applicant, California Construction and Roofing, Inc., filed a Conditional Use Permit application on September 12, 2007 and the most recent Land Development Committee (LDC) Meeting was scheduled for July 9, 2009. The applicant and their representative have been working in good faith to achieve resolution to most of the issues raised during the LDC Process.

CONCLUSIONS:

1. The proposed project is in conformance with the Community Development: Light Industrial (CD: LI) (0.25 - 0.60 Floor Area Ratio) land use designation, and with all other elements of the Riverside County General Plan.
2. The proposed project is consistent with the Manufacturing - Service Commercial (M-SC) zoning classification of Ordinance No. 348, and with all other applicable provisions of Ordinance No. 348.
3. The proposed project is conditionally consistent with the adopted policies of the Jurupa Valley Redevelopment Project Area (JVPA) (Rubidoux sub-area).
4. The public's health, safety and general welfare are protected through project design.
5. The proposed project is compatible with the present and future logical development of the area.
6. The proposed project will not have a significant effect on the environment.
7. The proposed project will not preclude reserve design for the Multi-Species Habitat Conservation Plan (MSCHP).

FINDINGS: The following findings are in addition to those incorporated in the summary of findings, and in the attached environmental assessment, which is incorporated herein by reference.

1. The project site is designated Community Development: Light Industrial (CD: LI) (0.25 - 0.60 Floor Area Ratio) on the Jurupa Area Plan.
2. The proposed use, contractor's storage yard for a construction and roofing company to store equipment, asphalt materials and shingles, construction and asphalt waste, is a permitted use in the Community Development: Light Industrial (CD: LI) (0.25 - 0.60 Floor Area Ratio) land use designation.
3. The project site is surrounded by properties which are designated Community Development: Light Industrial (CD: LI) (0.25 - 0.60 Floor Area Ratio) to the north, south, east and west.
4. The zoning for the subject site is Manufacturing - Service Commercial (M-SC).

5. The project proposes to permit a contractor's storage yard for a construction and roofing company to store equipment, asphalt materials and shingles, construction and asphalt waste, including six (6) parking spaces and 2,025 square feet of existing and proposed landscaping area on a 1.4 gross acre site. The existing 1,224 square foot office building and two (2) storage buildings, totaling 1,500 square feet, will be permitted and subsequently redeveloped. The conversion of the existing small structures from one use to another (as described above) will have minor modifications in the exterior of the structure for the sale of goods and services through the coordination of the Salvation Army. Pursuant to Article XI, Section 11.2.g., which states, "Any use that is not specifically listed in Subsections b. and c. may be considered a permitted or conditionally permitted use providing that the Planning Director finds that the proposed use is substantially the same in character and intensity as those listed in the designated subsections. Such a use is subject to the permit process which governs the category in which it falls."
6. The Planning Director finds, pursuant to Article XI, Section 11.2.g, that the contractor's storage yard for a construction and roofing company to store equipment, asphalt materials and shingles, construction and asphalt waste is substantially the same in character and intensity as those uses listed by Article XI, Section 11.2.c.(9), "Concrete batch plants and asphalt plants", and Article XI, Section 11.2.c.(14), Recycling or wood, metal, and construction waste".
7. The proposed use, contractor's storage yard for a construction and roofing company to store equipment, asphalt materials and shingles, construction and asphalt waste, is a permitted use, subject to approval of a conditional use permit in the Manufacturing - Service Commercial (M-SC) zone.
8. The proposed use, contractor's storage yard for a construction and roofing company to store equipment, asphalt materials and shingles, construction and asphalt waste, is consistent with the development standards set forth in the Manufacturing - Service Commercial (M-SC) zone.
9. The project site is surrounded by properties which are zoned Manufacturing - Service Commercial (M-SC) to the north, south, east and west.
10. Within the vicinity of the proposed project there is a church facility to the north, industrial and vacant land to the south, vacant land to the east and the Union Pacific Railroad to the west.
11. The Redevelopment Development Agency (RDA) has reviewed the proposed project and has determined that the project is conditionally consistent with the objectives of the Jurupa Valley Redevelopment Project Area (JVPA) (Rubidoux sub-area).
12. This project is not located within a Criteria Area of the Multi-Species Habitat Conservation Plan.
13. Environmental Assessment No. 41555 identified the following potentially significant impacts:
 - a. Cultural Resources

These listed impacts will be fully mitigated by the measures indicated in the environmental assessment, conditions of approval, and attached letters. No other significant impacts were identified.

Brief description of the existing environmental setting of the project site and its surroundings: The project site is located in the Jurupa Area Plan of the Riverside County General Plan. Urban entitlements have been approved or are currently being processed through the County of Riverside to the north, south, east and west. The 773,916 square foot Birtcher Center at Canal Street project (EIR00516) approved on September 9, 2009 by the Riverside County Planning Commission is located approximately 1,300 feet southwest of the project site. Vacant land, industrial uses, a church facility and the Union Pacific Railroad currently surround the project site. The project site is currently occupied by a contractor's storage yard for a construction and roofing company to store equipment, asphalt materials and shingles, construction and asphalt waste. Currently there is an existing 1,224 square foot office building and two (2) storage buildings, totaling 1,500 square feet to remain. The

topography of the project site is generally level, with a low elevation of approximately 880 feet above mean sea level over the majority of the property.

II. APPLICABLE GENERAL PLAN AND ZONING REGULATIONS

A. General Plan Elements/Policies:

- 1. Land Use:** The proposed project meets the requirements of the Community Development: Light Industrial (CD: LI) (0.25 - 0.60 Floor Area Ratio) General Plan Land Use Designation. The proposed project meets all other applicable land use policies.
- 2. Circulation:** The proposed project has been reviewed for conformance with County Ordinance 461 by the Riverside County Transportation Department. Adequate circulation facilities exist and are proposed to serve the proposed project. The proposed project meets with all applicable circulation policies of the General Plan.

Hi Christian,

Thank you for sending the latest exhibits and photographs for CUP 3564. This is a proposal to legalize a construction office and materials storage yard. The existing facility is well maintained, and the sides and back of the site are screen-fenced. The site is fully secured, and it is fenced and gated along Avalon Street with wrought iron. The office (a former residence), detached two-car garage and third building are painted, and the front of the project is landscaped with a lawn and planter. Based on our discussion yesterday, it is the RDA's understanding that the Planning Department is not requesting additional landscaping for the project site because it would not be located in the public viewshed; therefore, the additional cost to the applicant would far exceed any derived benefit to the public. The applicant has proposed 1,100 sq. ft. of landscaping (existing) on the site. No additional buildings are proposed for the project site. I have reviewed the RDA comment memo dated July 1, 2008. In this memo, the following items were requested for review prior to scheduling this case for a public hearing (P.2):

"Prior to scheduling this case for a public hearing, the RDA would like to review the following items that were not included in the original submittal package:

1. Color elevations with materials schedule for the existing structures shall be submitted to the Redevelopment Agency for review and comment.
2. A revised exhibit with trash enclosure area and correct landscape calculation shall be submitted to the Redevelopment Agency for review and comment.
3. A conceptual landscape/fence plan shall be submitted to the Redevelopment Agency for review and comment."

The RDA has the following comments to make regarding the above three requests contained in the memo dated July 1, 2008:

Item No. 1: The Planning Department has provided a photograph of the colors, materials and roofing shingles used on the existing structures. As such, this requirement has been met.

Item No. 2: The latest plot plan exhibit submitted by the Planning Department shows the location of a proposed waste collection area. While the exhibit has been modified and requirement has been met, the RDA would like to ensure that this area is designed to the standards of *Ordinance 348*—fully enclosed on three sides by a 6' masonry wall and gated (solid material). This serves the twofold purpose of enhancing on-site aesthetics and creates a more sanitary waste disposal/collection environment. Since the Planning Department has conditioned the project to meet the aforementioned standard, no additional condition will be required.

Item No. 3: This item requested submittal of a conceptual landscape and fencing plan for the project site. Item No. 2 requested a recalculation of the landscaping requirement on the site. It is important to reiterate that the subject site is screen fenced on three sides and fenced and landscaped in the front. The site is approximately 1.4-acres in size. While there is some storage (roofing tiles, pallets and several delivery trucks and lifts) on the site, most of the site is vacant and not utilized; no new structures are proposed, and all storage appears to be located along the sides or toward the back of the site. The front of the site contains 1,100 sq. ft. of existing, maintained landscaping. If the landscaping requirement is calculated based on the parking area, office and garage (front 20 percent of the site), the requirement would be approximately 1,216 sq. ft. Also, the RDA has conditioned this project to a maximum life of 10-years. As such,

the project is considered "temporary" in nature. Based on the aforementioned considerations, the applicant's existing landscaping appears to meet the minimum goals and objectives of the RDA in the sub-area.

This e-mail is considered an addendum to the RDA memo dated July 1, 2008. As such, the following two (2) conditions remain in effect (P.3):

General Conditions of Approval

As part of the conditions of approval for Conditional Use Permit 3564, the following condition(s) shall apply unless modified in writing by the EDA/RDA:

1. **Time Limit on Permitted Use / Deadline on the Submittal of an Application for Extension of Time Limit / Notification to the Executive Director of the Redevelopment Agency.** The applicant agrees that: the use approved under *Conditional Use Permit 3564* shall have a life of eight (8) years, with a possibility of one (1) two-year extension, for a maximum total life of 10-years, after which this approval shall become null and void. The two-year extension shall be granted, if at all, through the revised plot plan process or other appropriate development review submittal as determined by the Planning Director. The application for the two-year extension shall be submitted to the Planning Department no later than six (6) months prior to the end of the eight-year life of this permit. If the applicant does not apply for a revised plot plan or other approved development review submittal within the aforementioned timeframe stated in this condition of approval, the subject approval shall become null and void at the end of eight (8) years. PROJECT DESCRIPTION AND LOCATION:

Conditional Use Permit 3564 requests to legalize three (3) existing structures for a construction office and storage use in the community of Rubidoux. The project site is 1.40 acres located westerly and adjacent to Avalon Street and northerly of 28th Street. The three (3) existing structures consist of building "A," which is 1,224 sq. ft., building "B," which is 600 sq. ft., and building "C," which is 900 sq. ft. Building "A" will be used as an office with buildings "B" and "C" being used for storage purposes. The zoning for the project site is Manufacturing-Service Commercial (M-SC) and the land use designation is Light Industrial (CD: LI). Surrounding land uses include storage uses to the south, vacant land to the west and east, and a church to the north. There is a code violation associated with the project site (CV-07-3095).

REDEVELOPMENT PROJECT AREA(S):

The proposed project is located in the Jurupa Valley Project Area (JVPA) (Rubidoux sub-area).

REDEVELOPMENT AGENCY COMMENTS:

The mission of the Redevelopment Agency is to eliminate present blight and prevent the potential for future blight in and ultimately add value to, all redevelopment project areas by recommending approval of projects that meet the highest standards of quality possible. This is of particular concern in the Rubidoux sub-area where blighting conditions are still present. environmental degradation and issues relating to the health, safety and welfare of the public.

The Redevelopment Agency has the following concerns:

The exhibit for the proposed project indicates only 1,100 sq. ft. of landscaping. Per the development standards for the M-SC zoning, the project may be under landscaped.

There is no indication on the exhibit for the proposed project of the placement of a trash enclosure area. Per the development standards for Manufacturing- Service Commercial zoning, depending on the location of the proposed trash enclosure area, the area shall be screened on three (3) sides with a six (6) foot masonry wall and a solid gate screening on the fourth side so that it will not be visible from any public street or adjacent residential area.

Prior to scheduling this case for a public hearing, the RDA would like to review the following items that were not included in the original submittal package:

1. Color elevations with materials schedule for the existing structures shall be submitted to the Redevelopment Agency for review and comment.
2. A revised exhibit with trash enclosure area and correct landscape calculation shall be submitted to the Redevelopment Agency for review and comment.
3. A conceptual landscape/fence plan shall be submitted to the Redevelopment Agency for review and comment.

Please provide the information requested above to the RDA at stop # 1330. As soon as the materials have been received and reviewed, the RDA will have the information that it needs to discuss this project further and write additional conditions of approval if appropriate.

The Riverside County Waste Management Department (RCWMD) has reviewed the proposed project located in northerly of 28th Street and westerly of Avalon Street, in the Rubidoux Zoning District. In order to mitigate the project's potential solid waste impacts and to help the County's efforts to comply with State law in diverting solid waste from landfill disposal, the RCWMD recommends that the following conditions be made a part of any Conditions of Approval for the project:

1. **Prior to issuance of a building permit for EACH commercial building**, the applicant shall submit three (3) copies of a Recyclables Collection and Loading Area plot plan to the RCWMD for review and approval. The plot plan shall conform to ***Design Guidelines for Recyclables Collection and Loading Areas***, provided by the Waste Management Department, and shall show the location of and access to the collection area for recyclable materials, along with its dimensions and construction detail, including elevation/façade, construction materials and signage. The plot plan shall clearly indicate how the trash and recycling enclosures shall be accessed by the hauler.
2. **Prior to final inspection for EACH commercial building**, the applicant shall construct the recyclables collection and loading area in compliance with the Recyclables Collection and Loading Area plot plan, as approved and stamped by the Riverside County Waste Management Department and as verified by the Riverside County Building and Safety Department through site inspection.
3. a) **Prior to the issuance of a building permit**, a *Waste Recycling Plan* (WRP) shall be submitted to the Waste Management Department for approval. At a minimum, the WRP must identify the materials (i.e., concrete, asphalt, wood, etc.) that will be generated by construction and development, the projected amounts, the measures/methods that will be taken to recycle, reuse, and/or reduce the amount of materials, the

facilities and/or haulers that will be utilized, and the targeted recycling or reduction rate. Materials can be taken directly to recycling facilities (RCWMD, Recycling Section, can be contacted directly at 951.486.3200 for a list of facilities), or arrangements can be made through the franchise hauler and/or a construction clean-up business.

- b) **Prior to issuance of an occupancy permit**, evidence (i.e., receipts or other type of verification) to demonstrate project compliance with the approved WRP shall be presented by the project proponent to the Planning/Recycling Division of the RCWMD in order to clear the project for occupancy permits.
4. Hazardous materials are not accepted at Riverside County landfills. In compliance with federal, state, and local regulations and ordinances, any hazardous waste generated in association with the development of the project shall be disposed of at a permitted Hazardous Waste disposal facility. Hazardous waste materials include, but are not limited to, paint, batteries, oil, asbestos, and solvents. For further information regarding the determination, transport, and disposal of hazardous waste, please contact the Riverside County Department of Environmental Health, Environmental Protection and Oversight Division, at 1.888.722.4234.
 5. Use mulch and/or compost in the development and maintenance of landscaped areas within the project boundaries. Recycle green waste through either onsite composting of grass, i.e., leaving the grass clippings on the lawn, or sending separated green waste to a composting facility.
 6. Consider xeriscaping and using drought tolerant/low maintenance vegetation in all landscaped areas of the project.

Christian,

I am requesting a modification from landscaping standards per Ord.348, Section 18.12b for my CUP 3564 at 2651 Avalon Street, Riverside, CA 92509. I want to remove the landscaping requirement for the two proposed landscaping areas in the rear of the site that have absolutely no esthetic value or any other type of benefit to the community, drive-by traffic, and/or the adjacent neighbors. The 2,039 sq. ft. proposed landscaping site on the northeast property line cannot be seen from the street and is adjacent to an existing eight foot chain linked fence and a six foot existing block wall that blocks all sight of the area from the church and the church parking lot next door. The 2,518 sq. ft. proposed landscaping site on the opposite southwest property line also cannot be seen by the street and is separated from the adjacent rear construction yard by a eight foot chain linked fence with privacy slats. In addition, the two proposed landscaping sites would greatly reduce the required turning space for our trucks to enter and leave our long but very narrow parcel.

The removal of these two sites will reduce the total required landscaping sq. ft. to 2,025 which is below the 2,500 sq. ft. threshold for detailed landscaping requirements and exhibits as I understand it. To save the expense of revising my exhibits now to eliminate the two areas, I would like to wait until you have agreed to these changes and then I will provide you with new exhibits. In fact, if there is any way that we could just redline the two areas out on the existing plans I would greatly appreciate it.
